Re: Childcare for Critical Workers Monday 1st – Friday 12th February 2021

The Council and our schools are looking to determine provision for childcare from **Monday 1st – Friday 12th February 2021**. This provision, however, will be subject to the Welsh Government announcement, anticipated towards the end of this week and whether Local Authorities throughout Wales will still be required to provide remote learning for pupils. The situation remains under review, with the potential to be extended should this be considered necessary.

As an essential requirement and where no other childcare options are available, schools will offer a childcare provision for critical workers from Monday 1st February – Friday 12th February. The provision will be available between 8:30am - 3:30pm for eligible pupils, with the exception of <u>nursery</u>, the hours for which will be in line with your child/children's current nursery session times.

We will only consider placement for the children of critical workers (as defined by Welsh Government), in the following circumstances:

- where there are no other childcare options available to facilitate critical workers attending their place of work;
- where parents/carers are **unable** to work from home, and **must** attend their place of work as a critical worker; and,
- if your child/children are currently in one of the following year groups Nursery to Year 9 (up to 14 years only)

I need to take this opportunity to make it clear that, in order to reduce opportunities for transmission of COVID-19, this provision is intended only where there are no other alternative arrangements that are possible.

Provision will be based on availability of places within your child/children's school, with due regard given to staffing and remote learning requirements, along with the school's COVID Secure Risk Assessments. Therefore, places are not guaranteed. If there are more applications than places available, places will be allocated on a first come first served basis.





The Council welcomes correspondence in Welsh and English and we will communicate with you in the language of your choice, as long as you let us know which you prefer. Corresponding in Welsh will not lead to any delay.

All parents/cares will have to **provide their child with a packed lunch and snack, as no catering provision will be available**. However, free school meal direct payments will continue for eligible families who have been approved.



There will be no school transport provision available throughout this period.

Applications will need to be submitted <u>no later than 12 midday on Thursday 28th January</u> <u>2021</u>. We will be contacting existing applicants to determine their placement requirements. Therefore, if you have already applied for a place, please <u>do not</u> make another application.

Late applications will not be accepted.

Once an application has been approved, should the remote learning period be extended, you will not need to re-apply. We will contact you to determine your childcare requirements directly. Therefore, please ensure that your contact details are correct. I would also like to take this opportunity to remind parents that your child/children should not access this provision if they are:

- A confirmed case of COVID-19
- Experiencing symptoms of COVID-19
- Living with a confirmed case of COVID-19
- Identified as a contact of a confirmed case of COVID-19
- Living with someone with symptoms of COVID-19 and who is awaiting a test result
